Announcements by E-MAIL WILL NOT be accepted. Announcements by TELEPHONE WILL NOT be accepted. Please DO NOT CALL seeking confirmation of receipt of your announcement. If confirmation is wanted, please retain your fax confirmation. Any written announcements received after the deadline WILL NOT be considered.

Failure to appear at said Calendar Call, or to make announcement to said Judge as and when herein above provided, may, in the Court's discretion, subject the offending counsel or pro se party to the sanctions provided for in subsection (A) of the U.S.C.R. 20.

Whether a case shall be placed on the Ready List, Pre-Trial Calendar, or Trial Calendar shall be solely within the discretion of the Court, despite what announcement is made at Calendar Call (U.S.C.R. 8.1). No action will be continued merely by agreement of counsel (U.S.C.R. 8.5). If a case is not listed on this calendar and all parties agree that the case should be placed on the trial calendar, counsel or pro se party may contact the Clerk's office to add the case to the calendar call.
