Counsel shall also indicate whether the case has been mediated. If mediation has occurred or is scheduled, include the date of the session. If mediation has not occurred, state the reason(s) why.

Failure to appear at said Calendar Call, or to make announcement to said Judge as and when herein above provided, may, in the Court's discretion, subject the offending counsel or pro se party to the sanctions provided for in subsection (A) of the U.S.C.R. 20.

Whether a case shall be placed on the Ready List, Pre-Trial Calendar, or Trial Calendar shall be solely within the discretion of the Court, despite what announcement is made at Calendar Call (U.S.C.R. 8.1). No action will be continued merely by agreement of counsel (U.S.C.R. 8.5).
