If confirmation is wanted, please retain your fax confirmation. Any written announcements received after the deadline WILL NOT be considered.*

Failure to appear at said Calendar Call, or to make announcement to said Judge as and when herein above provided, may, in the Court's discretion, subject the offending counsel or pro se party to the sanctions provided for in subsection (A) of the U.S.C.R. 20.


